

## **LUIS MOLINA´S INTERNATIONAL COMIC AWARD. APPROVAL OF BASES.**

In a moment of great success of his work, Luis Molina has reprinted his series “comics”, made in the 60s, which have recently been published and finished .

The Luis Molina´s International Comic Award has been created in recognition of his work and to give continuity and difussion to the works developed in “comics”.

Taking into accuont the favorable opinion by the Commission of Culture, Education and Turism of November 7<sup>th</sup> 2006; the Town Hall unanimously agrees that:

- First: to create the Luis Molina´s International Comic Award in acknowledgment to his person and the work developped.
- Second: to approve the conditions to be applied in the contest. These are:

1. All the cartoonists, amateurs or professionals, at a worlwide level, can participate with any type of distinction.
2. The works have to be written in Spanish, English or French. The topic is free and each work will have a lenght of no more than 8 pages, in colour or black and white. There is total freedom regarding the size or the thecniques used in the works. All of them have to be original and unpublished.
3. All the works should be presented in support of paper, though they could be accompanied of other electronic or digital supports to ensure a correct reproduction in case of being selected. The works will have to be delivered in a closed envelope, including quality reproductions of every presented work, a photocopy of the D.N.I. (or passport) of the author, telephone number and/or e-mail.
4. The works have to be presented or sent by post to Blanca´s Town Hall, C/ Queipo de Llano, nº 7, 30540 Blanca (Murcia). The dead line to presente the works will be from January 8<sup>th</sup> to June 8<sup>th</sup> 2007. All those works which have the above mentioned date in the postmark of the post office will be accepted.
5. There will be only one award to the best work which will be of 3,000€ After knowing the veredict, Blanca´s Town Hall will request the author the original ones. Other works will also be selected for their excellent visual and literary labor and they will be included in the magazine of the contest.
6. The Jury will be formed by representants of Blanca´s Town Hall and for qualified experts in Arts. The Jury will award the prize and will decide on the aspects not solved in the bases, being these inappealable decisions.

7. The rewarded work, as well as the other selected works by the Jury, will be part of a magazine that will be edited by Blanca's Town Hall. Each author will receive five copies of the magazine, except for the winner who will receive ten of them.

The winning work will stay in Blanca's Town Hall and it will form part of the heritage of the community. The original one will be exposed in the Art Museum of the village. All the winning works, in consecutive years, not collected after the stipulated term, will remain in Blanca's Town Hall as another patrimonial value.

8. If the author does not deliver the rewarded original work in a minimal stipulated term, the award will pass to another cartoonist from the selected ones by the Jury and represented in the published publication.

9. The winner and the winner work there will be granted the major possible advertising and informative diffusion.

10. The not rewarded or selected works will be informed by means of the mass media and the link in the web of Blanca's Town Hall: [www.blanca.es](http://www.blanca.es).

11. Blanca's Town Hall will contemplate an economic endowment for the travelling and other expenses (feeding and housing) of the winning author to the city, in order to attend the delivery of prizes. It will take place during the month of September together with the inauguration of the exhibition of the published works in the cultural centre of exhibitions of the village.

12. The participation in this contest involves the complete acceptance of these bases. In case of any unpredicted aspect, they will be solved by the organization or the Jury.
